

PWGSC Learning Services SO/SA Overview

The Government of Canada purchases professional services through contract vehicles such as standing offers (SO) and supply arrangements (SA). In some cases, the use of an SO or SA is mandatory.

The Learning Services SO and SA are the two mandatory contract vehicles for contracts related to the design, development and delivery of a range of learning services including traditional classroom learning, blended learning and eLearning.

PWGSC Learning Services SA

Description

The Learning Services SO/SA comprises two mandatory procurement tools for most purchases of learning services to be provided to locations across Canada. It includes all aspects of the design, development and delivery of classroom learning, blended learning and eLearning product development. In general, the provision of services involves the development and delivery of government-owned materials.

The Learning Services SO/SA includes the streams and categories listed in Attachment #1.

By qualifying for Learning Services, your firm will become eligible to provide services to support the Government of Canada's learning services activities including the provision of advice, instructional design and development, eLearning product development, and multi-media design and development.

The Learning Services SA is for contracts of any dollar value, typically awarded using a best value (technical + financial) evaluation. The Learning Services SO is for contracts of any dollar value, up to \$250,000, to be awarded on a ranked (low cost) right of first refusal basis.

Solicitation Highlights

The Learning Services SO and SA are currently closed for bids. A renewal for both the SO and SA is anticipated for September 2016.

Key Requirements:

- Three years in business
- A minimum dollar value of billed services relevant to each proposed stream (the amount varies, please see Attachment #1 for details of stream-specific requirements)
- Security clearance (prior to SA award)

A proposal requires both a hard copy and the entry of data into the Centralized Professional Services System (CPSS).
